NATIONAL OPEN CALL FOR TENDERS No. 007 /AONO/PAK/CIPM/2024 OF 01 FEB 2024 TO EXTEND AND REINFORCE THE UTILITY NETWORKS OF THE PORT AUTHORITY OF KRIBI IN TWO (2) LOTS. LOT 1: EXTENSION OF THE FIRE-FIGHTING WATER NETWORK IN THE LOGISTICS ZONE; LOT 2: REHABILITATION OF THE WASTEWATER TREATMENT PLANT.

FUNDING: Budget of the Port Authority of Kribi, 2024 FY

1. Purpose of the Call for Tenders

Within the framework of extending its utility networks, the General Manager of the Port Authority of Kribi, Project Owner, hereby launches a National Open Call for Tenders to extend and reinforce the utility networks for the Port Authority of Kribi in two (2) lots:

- Lot 1: Extension of the fire-fighting water network in the logistic zone.
- Lot 2: Rehabilitation of the wastewater treatment plant.

2. Nature of services

2.1. Lot.1 Extension of the fire-fighting water network in the logistic zone.

Services shall include:

1. General works:
 - Site set-up and removal
 - Studies and implementation plans
 - Inventory document...
2. Supply and transport of pipes, sleeves and other parts
3. Supply of taps, suction pads and drainage system
4. Earthworks
5. Manufacture of manholes for suction pads and hydraulic parts



6. Special work (if necessary):
 - Under-pavement drilling
 - Laying pipes under gutters
 - Connection to the central network
 - Crossing of gutters and culverts
7. Laying the pipework and fire hydrants
8. Various work:
 - Pipe cleaning, disinfection and sterilisations
 - Bacteriological analyses

2.2. Lot 2: Rehabilitation of the wastewater treatment plant

Services include maintenance and re-commissioning of equipment of the Kribi Port wastewater treatment plant.

This shall entail:

- Upgrading the wastewater collection and transfer network to the treatment plant
- Rehabilitating the pre-treatment system (oil separator and bar screen) at the head of the plant
- Rehabilitating treatment facilities (buffer tank, clarifier, reaction tanks, filter press, air blowers, sludge thickening cyclone)
- Rehabilitating disinfection reagent dosing system
- Rehabilitating the waste disposal system

3. Provisional execution time

The provisional time provided for by the Project Owner to carry out the services covered by this Call for Tenders shall be six (6) months for each lot.

4. Allotment

Services shall be divided in two (2) lots:

Lot 1: Extension of the firefighting water network in the logistic zone

Lot 2: Rehabilitation of the wastewater treatment plant



5. Provisional cost

The provisional cost after prior studies is:

- Eighty million (80,000,000) CFAF for lot 1;
- Eighty million (80,000,000) CFAF for lot 2.

6. Participation and origin

This Call for Tenders is open to companies incorporated under Cameroonian law with competence and references in providing the services mentioned in the lots above.

7. Funding

Services covered by this Call for Tenders shall be funded by the Budget of the Port Authority of Kribi, 2024 FY and allocated as follows:

- ***Task 5116001 "Rehabilitation of water networks", line 5116001-624830 "Maintenance and repair of port equipment and facilities"***
- ***2024 FY, Task 5116001 "Rehabilitation of water networks", line 5116001-231110 "Industrial buildings"***

8. Bid bond

Bids must be accompanied by a bid bond issued by a first-rate banking institution approved by the Minister in charge of finance (see Document 14 in the Tender File) to be automatically released no later than 30 days after the expiry of the validity of the tenders and amounting to:

- **Lot 1: one million six hundred thousand (1,600,000) CFAF.**
- **Lot 2: one million six hundred thousand (1,600,000) CFAF.**

The copy of the receipt shall be submitted when collecting the Tender File at the Public Contracts Division of the Port Authority of Kribi.

11. Submission of bids

12. Admissibility of bids

Under penalty of rejection, administrative documents required must be provided in originals or copies certified by the issuing institution or the competent administrative authority in accordance with the provisions of the Specific Rules of the Call for Tenders.

They must have been issued less than three (3) months before the original date of submission of bids or after the signing date of the Tender File.

Any bid deemed incomplete at the end of the moratorium granted by the Internal Procurement Committee in accordance with the provisions of the Tender File shall be declared inadmissible.



13. Opening of bids

The opening of bids shall be done in one stage and shall take place on 05 MARS 2024 at 1 p.m. by the Internal Procurement Committee of the Port Authority of Kribi in the Conference Room located on the **2nd floor of the PAK 2-storey building in Kribi.**

Bidders or their duly mandated representatives shall attend this opening session.

14. Eliminary criteria

1) Insufficient number of copies (less than 7 copies)

2) Administrative file

- Incomplete administrative;
- Non-compliant administrative document after the 48-hour deadline granted by the Internal Procurement Committee;
- False statement or forged document.

3) Technical file

- Non-compliance with 5 key criteria out of 7;
- No site visit certificate signed by the Project Owner's services;
- Non-acceptance of the terms and conditions of the contract (Specific Technical Specifications (CCTP), Special Administrative Specifications (CCAP), declaration of commitment to comply with the social and environmental clauses or Integrity Charter) not initialled on each page, not signed, not sealed and not dated by the bidder on the last page);
- False statement or forged document.

4) Financial file

- No quantified unit price sub-details;
- No quantified unit price.

16. Award

The contract will be awarded to the most competitive bid. A bidder cannot be awarded more than one lot.

17. Validity of offers

Bidders will remain committed to their offers for ninety (90) days from the deadline set for the submission of tenders.
