1. Purpose of the Call for Tenders

In order to optimize the utility systems of the Port Authority of Kribi, the General Manager of the Port Authority of Kribi, Project Owner, hereby launches a Call for Tenders to service the PAK new premises in three (3) lots.

2. Nature of services

Services shall be specified in the Technical Specifications and in the Unit Price list and shall include:

Lot 1: supply and installation of generators in the PAK new premises: RDLA, YAOU

- > Supply and installation of 160 KVA soundproof generators including accessories and generator room;
- Factory production control and equipment testing;
- Equipment testing and commissioning;
- Capacity-building for five (5) PAK staff in operating and maintaining installed equipment.

Details on the equipment shall be specified in the Special Technical Specifications.

Lot 2: supply and installation of UPS and voltage regulators in the PAK new premises: RDLA, YAOU, Emergence 2, Domayo, R+1

- > Supply and installation of voltage regulators and UPS in the new PAK premises;

> Capacity-building for five (5) PAK staff in operating and maintaining installed equipment.

Details on the equipment shall be specified in the Special Technical Specifications.

Lot 3: supply and installation of air-conditioners in the PAK new premises: DLA AND YAOU:

- > Supply and installation of air conditioning and cooling units and all their accessories in the new PAK premises;
 - Equipment testing and commissioning;
 - > Capacity-building for five (5) PAK staff in operating and maintaining installed equipment.

Details on the equipment shall be specified in the Special Technical Specifications.

3. Execution time

The provisional time provided for by the Project Owner to carry out the services covered by this Call for Tenders shall be six (6) months for each lot.

4. Allotment

This Call for Tenders shall be divided as follows:

- \triangleright lot 1: supply and installation of generators in the PAK new premises: RDLA, YAOU
- lot 2: supply and installation of UPS and voltage regulators in the PAK new premises: RDLA, YAOU, Emergence 2, Domayo, R+1
- lot 3 : supply and installation of air-conditioners in the PAK new premises: DLA AND YAOU

5. Provisional cost

The provisional cost for all the services is **two hundred and twenty million** (220,000,000) CFAF all tax inclusive broken as follows:

- Lot 1: eighty million (80,000,000) CFAF all tax inclusive;
- Lot 2: eighty million (80,000,000) CFAF all tax inclusive;
- Lot 3: sixty million (60,000,000) CFAF all tax inclusive.





6. Participation and origin

This Call for Tenders is open to companies incorporated under Cameroonian law specialized in providing such services, i.e., manufacturing or selling the type of equipment specified in the Technical Specifications.

7. Funding

Services covered by this Call for Tenders shall be funded by the Budget of the Port Authority of Kribi, 2024 FY and allocated as follows:

- 2024 FY, Task 5116003 "Rehabilitation of electrical networks", line 5116003-244900 "Electrical equipment";

11. Bid bond

Bids must be accompanied by a bid bond issued by a first-rate banking institution approved by the Minister in charge of finance (see Document 14 in the Tender File) to be automatically released no later than 30 days after the expiry of the validity of the tenders and amounting to:

- Lot 1: one million six hundred thousand (1,600,000) CFAF;
- Lot 2: one million six hundred thousand (1,600,000) CFAF;
- Lot 3: one million two hundred thousand (1,200,000) CFAF.

12. Admissibility of bids

Under penalty of rejection, administrative documents required must be provided in originals or copies certified by the issuing institution or the competent administrative authority (DO, SDO...) in accordance with the provisions of the Specific Rules of the Call for Tenders.

They must have been issued less than three (3) months before the original date of submission of bids or after the signing date of the Tender File.

Any incomplete bid as per the requirements of the Tender File shall be declared inadmissible, namely for the lack of a bid bond issued by a financial institution or a first-class bank approved by the Ministry of Finance.

13. Opening of bids

The opening of bids shall take place in one stage.

The opening of administrative, technical, and financial files shall take place on at 1 p.m. by the Internal Procurement Committee of the Port Authority of Kribi in the Conference Room located on the 2nd floor of the PAK 2-storey building in Kribi.

Bidders or their duly mandated representatives shall attend this opening session.





14. Eliminatory criteria

1) Insufficient number of copies (less than 7 copies)

2) Administrative file

- Incomplete administrative file;
- Non-compliant administrative document after the 48-hour deadline granted by the Internal Procurement Committee;
- > False statement or forged document.

3) Technical file

- Non-compliance with 5 key criteria out of 7;
- No site visit certificate signed by the Project Owner's services;
- Non-acceptance of the terms and conditions of the contract (Specific Technical Specifications (ST), Special Administrative Specifications (CCAP), declaration of commitment to comply with the social and environmental clauses or Integrity Charter) not initialled on each page, not signed, not sealed and not dated by the bidder on the last page);
- > False statement or forged document.
